3. **Technical Specification of LRS Approved Steel Plate (Grade AH-36) and MS Bulb profile.**

- Each MS plate shall have a punched Heat number and Batch number duly stamped by the International Classification Society - LRS.
- Each bundle of MS Bulb profile shall have a sheet metal sticker mentioning Heat number and Batch number duly stamped by the International Classification Society (LRS).
- Mill test certificate endorsed by LRS is also to be supplied along with shipping documents.
- All the materials are to be tested by LRS classification Society and test certificate endorsed by the LRS showing Heat No and Batch No is to be submitted along with shipping documents.

- e. Manufacturer certificate regarding the chemical composition and mechanical properties is to be provided along with shipping documents.
- f. Plus/minus 5(five) percent tolerance to be allowed on total quantity and dimension (Length and breadth). In case of thickness, positive thickness is acceptable but not countable with the weight. On the other hand, Negative thickness is not acceptable at all.
- g. Each plate and bulb profile is to be without shop primed before shipment.
- h. Weight will be counted as per theoretical weight basis.
- i. Country of Origin: To be mentioned.

5. **Bidder's Qualification Documents to be submitted.**

- a. Valid Trade License.
- b. Business Registration Certificate/ Article of incorporation/ association.
- c. TIN/ equivalent certificate.
- d. Bank Solvency Certificate.

6. **General Condition.**

- a. Article wise compliance statement fulfilling the requirement of the EOI is to be submitted for evaluation of the quotations. Stating mere 'Yes or No' will not suffice and detailed description/ information, brochures (as required) is to be given. An incomplete compliance statement in any part may attribute to cancellation of the offer. If any clause of this specification does not commensurate with the requirement, the deviation must be spelt out clearly.
- b. Financial offer should be quoted in USD/ EURO /BDT
- c. FOB price is to be clearly mentioned in the offer.
- d. CFR price is to be clearly mentioned in the offer.

7. **Evaluation.** Among the technically responsive bidder/ bidders, KSY will consider the lowest bidder for evaluation. During evaluation phase, KSY will establish direct contact with the top management of manufacturers. In this respect Bidders should provide necessary links/ contact details in under to ensure the genuinity of the manufacturers.

8. **Manufacturer/ Steel Mill Details.** The intended steel mill should be LRS approved and related certification of steel mill are to be submitted along with steel mill name, full address, telephone number, e-mail address. In addition, sample mill test certificate of previous order of the mentioned steel mill is also to be submitted along with the offer.



9. **Authorization Letter.** Manufacturer authorization letter on behalf of principle/ supplier (if the manufacturer is not the supplier) will have to be submitted at the time of offer. In case of authorization from the supplier, authorization of the said supplier from the manufacturer also need to be submitted with the offer.
10. **Pre-shipment inspection (PSI).** Pre-shipment inspection (PSI) will be conducted by KSY or KSY nominated third party. The cost of Pre-shipment inspection shall be borne by KSY. The supplier/ seller should intimate the inspection date at least 15 days prior to the readiness of the inspection. Based on satisfactory PSI report and taking clearance from KSY, seller will ship the goods.
11. **Performance Guarantee (PG).** 5% Performance Guarantee (PG) of the total contract price (TCP) will have to be submitted within 15 days after issuance of NoA and before signing the contract. Validity of the PG should be upto delivery of the goods and final acceptance by the buyer. Failure to furnish PG will be considered as non-responsive.
12. **Pitted or 2nd Hand MS Plate and bulb profile.** If any pitted or 2nd hand MS plate and bulb profile is found during the joint mustering of KSY & supplier at KSY premises, the pitted or 2nd hand MS plate and bulb profile will not be acceptable, supplier shall undertake the full responsibility to supply and replace the pitted or 2nd hand MS plate and bulb profile by new one.
13. **Payment Terms.** KSY will open 100% irrevocable letter of credit from any schedule of Bangladesh in favor of the supplier. Total contract price will be released after producing the following documents in the buyer's bank:
- Non-negotiable Bill of Lading Marked freight "prepaid".
 - Invoice duly signed in ink indicating unit and total price of individual item.
 - Certificate of origin.
 - Pre-shipment inspection report.
 - Manufacturer's certificate.
 - Undertaking certificate.
 - Copy of intimation given to KSY appointed Insurance Company for covering insurance.
14. **Shipment Time.** Shipment will be done within 50 days after LC opening. Early shipment will get priority.
15. **Validity.** Offer validity will be 60 days from the submission date of offer.
16. **KSY reserves all the right to accept/ reject all or any part of the bidder's offer against this EOI without showing any reason.**
17. **Deadline of offer submission.** Interested bidder should submit their technical and financial offer or before **04 June 2023.**
