Each MS plate shall have a punched Heat number and Batch number duly stamped by the International Classification Society - LRS/DNV -GL/ABS/NKK/BV.	20000000
2. Mill test certificate endorsed by LRS/DNV -GL/ABS/NKK/BV is also to be supplied along with shipping documents.	
3. All the materials are to be tested by LRS/DNV-GL/ABS/NKK/BV classification Society and test certificate endorsed by the LRS/DNV-GL/ABS/NKK/BV showing Heat No and Batch No is to be submitted along with shipping documents.	nen energi
4. Manufacturer certificate regarding the chemical composition and mechanical properties is to be provided along with shipping documents.	
5. Plus/Minus 10(ten) percent tolerance to be allowed on total quantity and dimension (Length and breadth). In case of thickness, positive thickness is acceptable but not countable with the weight. On the other hand, Negative thickness is not acceptable at all.	
6. Each plate is to be without shop primed before shipment.	
7. Weight will be counted as per theoretical weight basis.	

3. Terms Conditions:

- a. Bidder should offer Lot-1 and Lot-2 together as mentioned in the scope of supply.
- b. Partial/ Incomplete offer is not acceptable and will be treated as non-compliant.
- c. Article wise compliance sheet to be filed by the bidder,
- d. Among the technically responsive bidder/bidders, KSY will consider lowest bidder for evaluation.
- e. The manufacturer details such as brochure or catalogue in English language is to be submitted with the offer.
- f. Pre-Shipment Inspection (PSI) may be conducted by KSY nominated 3rd party. The cost of nominated 3rd party inspection shall be borne by the KSY. In that case after acceptance of 3rd party inspection report, seller will ship the goods.
- g. Manufacturer authorization letter on behalf of supplier (other than manufacturer is the supplier) will have to be submitted at the time of offer.
- h. 5% Performance Guarantee (PG) of the total contract price (TCP) will have to be submitted after issuance of NoA and before signing the contract. Validity of the PG should be upto delivery of the goods and final acceptance by the KSY. Failure to furnish PG will be considered as non-responsive.
- i. KSY will open 100% irrevocable letter of credit from any schedule of Bangladesh in favor of the supplier. The payment will be released after producing the following documents in the buyer's bank
 - (1) Non-negotiable Bill of Lading Marked freight "prepaid".
